Summary

Highlights since January 2017



- From the 7th of January 2017 to the 31st of March 2017, 173 datasets were processed, including new collections and updates; the total amount of records increased by 222.924.
- More than 38% of Europeana Collections is open for re-use without restrictions.
- Fashion Collection has been launched, and updates related to Sound Collection have ended, according to the conclusion of this program.
- The Poetry Campaign has started, with the result of providers sending data updates regarding related content.
- Some inactive providers with broken links have been cleaned up.
- Extensive mapping and processing jobs are currently in progress in order to update and extend data from BHL Europe, while the Victoria and Albert Museum API is currently under investigation for direct harvesting (and therefore implementing this new data in Europeana).

Overview

Currently Europeana.eu features content from 44 countries in 39 languages across more than 3,330 data providers. In total there are **54.358.074** objects available in Europeana.eu. Several partners have submitted new or updated metadata to Europeana in the last months, including the Instituto del Patrimonio Cultural, OpenUp!, BHL Europe, the Slovenian National Aggregator, EUscreenXL, PartagePlus and Europeana Space.

In line with the Europeana Foundation's business plan and working towards its strategic plan 2015-2020, Europeana is working on improving the richness and the quality of the metadata present in the Europeana repository. This is being achieved by asking Europeana's partners to review the presence, quality and consistency of metadata fields, such as the description, title, date (created or issued), coverage (spatial or temporal). In addition to this Europeana is focusing on increasing the number of digital objects labelled with rights statements that enable re-use, and also on the provision of direct links to media files of high quality.

Quality improvements have a very high priority and together with our partners we invest a lot in moving collections up the tiers of the Europeana Publishing Framework or improve metadata quality to improve discoverability of collections in Europeana. In addition to lots of planning work and content analysis we also achieve very good results, which these examples should illustrate:

- In the context of the Poetry Campaign, Iceland has changed rights from In Copyright to Public Domain, and NL Zagreb updated its set with poems labeled as Public Domain;
- The EFashion sets were improved with more specific values/layout for dc:creator fields;
- Improvements of datasets from the Slovenian National Aggregator (lang attributes, more specific fields, institutions label normalisation);
- Working to fix duplicates between PartagePlus-Cyfrowych and PartagePlus Arts Council Norway;
- Publishing dataset Dutch Labour Party after a lot of negotiation on rights and higher image size.

Content in Europeana by Country Top 15

Looking at the country division of metadata throughout the **54,135,150** digital objects available in Europeana.eu. Germany, France, the Netherlands, Spain, Sweden, Italy and United Kingdom provided the majority of the content in Europeana.eu. Countries contributing less than one per cent of the content are Portugal, Slovenia, Switzerland, Slovakia, Lithuania, Luxembourg, Israel, Malta, Russia, Bulgaria, Romania, Latvia, Turkey, Serbia, Cyprus, Croatia, Iceland, United States of America and Ukraine.





Figure 1. Content in Europeana by country




Figure 4. Europeana Content by Copyright Status.
