I. Approval and adoption of minutes, decisions & actions of 12 March 2020 meeting

III. Positioning during and post pandemic; Digital Europe Programme



As the immediate response to the COVID-19 crisis we undersigned a number of important petitions and launched the new Europeana Collections and Europeana Pro - good timing for us as a hub for the sector. What do we do now to position ourselves in the sector? We should not overreact too quickly just to be part of the response. The Europeana Strategy sets our 3 priorities around capacity building which is quite complex, data quality and infrastructure. Based on NEMO's Survey on the impact of the COVID-19 situation on museums in Europe, 60% of museums have increased their digital activities, 30% have asked staff with no background in digital to take up new digital responsibilities. This underlines a capacity gap. We've designed a mini strategy to create a capacity building framework in 6 to 9 months including a series of sense-making workshops. We have to play a role in shaping the new normal in the sector post COVID-19. To mark the 70th anniversary of the Schuman Declaration, we have launched an exhibition and on Saturday 9 May together with Europa Nostra we are co-hosting Europe Day Webinar to look at how cultural heritage can be a powerful catalyst for the future of Europe¹. At the 15 June Board meeting we share more on how as an organisation we can and should act in this environment.

IV. Finance

Decision: The Board approved the 2019 annual accounts and financial report with a quorum.

VI. Management report and next meeting

To build a global consensus on Open Science, UNESCO is developing the Open Science Recommendation and is gathering inputs from all the interested stakeholders, through an online consultation, regional and thematic meetings and numerous debates on implications, benefits and challenges of Open Science. The consultation is open until mid June and Europeana can be a player.

Next meeting of the Board will be held on 15 June at 16h30 CEST via GoToMeeting.
