Executive Summary

This Deliverable (EuropeanaConnect Deliverable D6.1.1 – First Content Collection) delivers over 100,000 digital music audio objects (plus a small number of additional related items including video, images and text) to Europeana for immediate access.

1. Introduction

During the first 18 months of the project, WP6 made considerable efforts to aggregate new content providers, as specified in the Description of Work. At the time of writing, 69 content providers (see appendix 1) have submitted their audio data to the EuropeanaConnect Audio Aggregation Platform (AAP) <http://www.dismarc.org/> for subsequent harvesting by Europeana.

Content owners, including sound archives, broadcasters, institutions such as museums and libraries, record companies, etc.) were sent the regular AAP Newsletter, which was followed up by individual invitations to deliver content to Europeana. In almost all cases, the recipients were aware of the DISMARC/EuropeanaConnect project. Discussions led, in most cases, to a fruitful conclusion, with delivery of content.

In a minority of instances content owners preferred to deliver their material either themselves or via another content aggregator. A very small number of content owners were still at the beginning of the process of creating a digital archive, and will be followed up when appropriate.

The current total of digital items which have been harvested from the AAP and which are now available via the Europeana platform is 110,730 (data retrieved 11/10/2010).

2. Details of content

2.1 Formats:

As noted above, the current total of digital items which have been harvested from the AAP and which are now available via the Europeana platform is **110,730** (data retrieved 11/10/2010).

As well as **101,228** music audio items, there are an additional **6,692** text items, **2,798** images and **12** videos. These additional items are all related to accompanying music items; they include album covers, manuscripts, demonstrations of folk dances, etc.

2.2 IPR:

Content delivered to Europeana is either in the public domain (approximately 20%) or is protected by various IPR restrictions. Where the material is in the public domain, it will (from the end of October 2010) be marked by the Public Domain Mark <http://creativecommons.org/publicdomain/mark/1.0/>. Where IPR restrictions are applicable to the content, content owners have agreed to deliver extracts from their original audio files, usually at reduced quality (mp3 196 kbs). Material which is IPR-protected will be flagged by the relevant CC license (from the end of October 2010). In this manner, contemporary audio which is protected by IPR is nonetheless available via Europeana. Users have the option to follow links to access full-length, full-bandwidth versions. Extracts usually consist of between

30 seconds and 1 minute 30 seconds of audio, and the duration of the extracts is visible in the Europeana search results.

2.3 Hosting:

Audio extracts are either hosted by the content provider or, where content providers have no audio server, on the DISMARC/EuropeanaConnect Audio Aggregation Platform itself, at no cost to the content owner.

2.4 Europeana Content Provider Agreement:

After discussion with the Europeana office, it became clear that all audio aggregated under the EuropeanaConnect Description Of Work is covered by the DoW. We are advised that it is therefore unnecessary for content providers who are providing their content via EuropeanaConnect to sign an agreement with Europeana while the project is still running.

3. Workflow

Following an archive/content provider's agreement to deliver content to the AAP for harvesting by Europeana, a test sample of data is sent to the WP6 technical partner AIT – Applied Information Technology Ltd. AIT creates a mapping in order to conform the data to the ESE schema [ESEv3.2XMLSchema](#) and to identify any data which may be missing.

When a test mapping has been created, the content owner is invited to give his/her response to data presented via the AAP test server.

Following the content owner's approval, the data are then uploaded and checked on the Europeana Content checker [EuropeanaContentChecker](#).

Following a successful completion of this process, Europeana is notified that an AAP harvesting is requested.

Finally the content owners and the AAP agree on an update procedure, and the content owners are provided with tools to enable future automatic uploads/updates of their content (using FTP/OAI-PMH).

4. Future

During the remaining year of the EuropeanaConnect project, aggregation will continue. We anticipate that there will be no difficulty in reaching the projected figure of 200,000 music audio items by the conclusion of the project.
