To receive feedback from users, we measured user satisfaction as well as Net Promoter Score (NPS) of Europeana Collections quarterly. In the last year, these were measured on two occasions (December 2018, April 2019). On average, 83% of the Europeana Collections users surveyed, rated as being satisfied, very satisfied or totally satisfied with the website. Europeana Collections also achieved a good NPS score, with an average of 38.

Based on a small feasibility study related to the Single Sign On (SSO) functionality we implemented a technical solution for the login functionality this year. The feasibility study happened before implementing keycloak, which is the tool that supports the authentication and authorisation for login. Next year, EF is planning to complete user research to understand what type of functionality users need login services for. The idea is to create one login functionality across all products. So that a user is able to use the same login for Europeana Pro, Metis and Europeana Collections and each site will offer services that the user can interact with behind the login. The study will complete user research to validate this idea and feasibility research to understand what it would take to deliver this concept. The user research is delayed, as mentioned above the scope of the study changed to involve a more elaborate outcome. This study will feed into plans and next steps to

### 3. Key Performance Indicators

KPIs as defined for the first year of the tender (1 September 2018 until 31 August 2019) are detailed in the table below. The table states the KPIs related to the individual work package, how the KPI is measured, and the target towards the KPI to be reached by 31 August 2019.

Our main KPIs for Europeana Collections including traffic generated to Europeana Collections as well as user return rate are behind target. Main source of traffic remains organic search with multiple niche searches. This is a sign of a long tail-traffic on which we have limited influence on. We are still experiencing a high level of dependency on Google. Our efforts on Search Engine Optimisation (SEO) such as publication of Schema.org for our entity and item pages shall make these pages more visible on search engines such as Google. Particularly successful in generating traffic was curated content such as blogs and exhibitions confirming our efforts towards SEO of curated content. We will continue to focus on the generation of traffic to areas of the website we do have control over (thematic collections, exhibitions, galleries, blogs), also via our various communication and dissemination efforts. Additionally, we worked on diversifying traffic sources by developing various traffic sources to reduce the dependency on Google. These efforts will complement the work done on the product side to enhance the overall portal experience to encourage new and returning visitors visitors. This should result in an improved user experience and extended user journey.<sup>12</sup>

Number of click-throughs is behind target. We assume that as data quality improves over time on Europeana Collections there is less need for users to click-through to partners websites to explore the content. To increase traffic to partners' websites we placed the partner institutions prominent on the new record page, visible for users to click.

Our two main KPIs for data quality (KPI 2.8 and KPI 2.9) are above target. Since the last measurement of tier statistics in February non-EPF-complaint records are discarded in the statistics. Additionally, the high value for tier 4 are due to the fact that 2.5 million records are currently classified as tier 4 that are not expected to count for tier 4 in the future. The National Archives of Norway is currently providing page level access to lots of their documents. We should provide book level access to these documents instead. With that in place, the total content in Europeana Collections as well as the tier 4 content will drop by 2.5 million, which will reduce the total in tier 4 by about 4 percent points.

In July 2019, EF surveyed all accredited aggregators to Europeana DSI<sup>13</sup> and the data providers of the DSI aggregating partners. The percentage of surveyed CHIs that rate the relation with its aggregator (partner in Europeana DSI-4) 4 or higher on a likert scale of 1-5

is 85%. The CHI survey was filled by 37 CHIs from 9 aggregators. The low response rate may be explained with the fact that many colleagues were on vacation. Another explanation may be that not all CHIs are equally active working with the aggregator on their data in a certain time period. Next year we plan to run the survey earlier in the year and discuss with the aggregators how to increase the response rate. The percentage of surveyed aggregators that rate the relation with Europeana 4 or higher on a likert scale of 1-5 is 55%. Out of 33 accredited aggregators 22 filled the survey. EF will further analyse the results and identify actions to improve the satisfaction of aggregators.

For the KPI 2.12 Number of broken links (out of total) we are currently not able to provide this metric. The functionality to give this information is scheduled for development for Q4 2019.

Research was undertaken between June and July, to monitor the state of implementation of rightsstatements.org into the certified aggregators infrastructure (KPI 2.14). 28 of 33 certified aggregators were interviewed. The interview results combined with our operational knowledge shows that 20 active aggregators (61%) had implemented the statements into their infrastructures, exceeding our target of 25% for August 2019. We also saw some evidence that the statements are being adopted further into the data partner chain, with five aggregators indicating at least one of their partner institutions who had adopted the statements.

Total number of integrations of Europeana data in dynamic learning environments is behind target. Currently we are in contact with two learning platforms (one commercial and one ministry related) to integrate Europeana resources via our API. The work with educational partners during the first year of Europeana DSI-4 showed low interest in the API integration of the whole (or selected) Europeana Collections; instead, the partners had a clear preference for featuring curated and ready-made resources (for example, learning scenarios or source collections) in their systems and portals. In addition, the commercial partners are the least responsive group out of our three target ones (governmental, noncommercial and commercial) which is often related to their own product development priorities.

Total number of cases of new works, products or services using Europeana content in the creative industries market are behind target. The creative industries market is large and heterogenous and thus the outreach activities there are time and labour intensive. Considering the available limited resources at EF and the higher priority of other markets (for example, education), our work with the creative industries professionals was rather limited so far under Europeana DSI-4.

We perform very well on social media with almost twice as much users reached as initially targeted.<sup>14</sup>

The number of task forces is below the target. Task forces are created when there is a specific need based on work undertaken under Europeana DSI and also other projects (such as Generic services projects). Currently we support three task forces with a specific purpose, endorsed by the communities. In addition, the role of the task forces as originally planned in the tender, is currently taken over by the ENA community steering groups, who address relevant topics in their own way.
