### 1 Introduction

### 1.1 Background

This deliverable is part of Work Package 4 (WP4). The **objective** of the WP is to use the tools, connectors and interfaces developed under WP 3 (Development) to deliver a large quantity of rich digital content, including images and associated metadata, for ingestion into Europeana.

WP4 is responsible for the **coordination of content**: more than 960,000 records will be delivered to Europeana using the Europeana Connection Kit (ECK).

This report is part of *Task 4.2 – Full content export:* following the evaluation of the control export (task 4.1) this task will then implement a full export of the content to be contributed to Europeana from the content partners systems.

The ingestion is performed in a 2-stage approach to ensure a robust transfer of data from network participants to Europeana:

- Stage 1: A test ingest of a small 'package of records' from each content contributor to assess the robustness of the system and identify any potential issues in metadata cross-mappings.
- Stage 2: A full ingest of more than 960,000 records from content providers and Aggregators into Europeana

### 1.2 Role of the deliverable in the project

The full content ingestion in Europeana will take place on a **staggered basis**. This deliverable presents the **schedule** with the overall structure and sequence for content delivery. It specifies the order in which participating institutions will carry out the export of their data using the ECK.

WP4 is dependent on the outputs of WP2 and WP3 for its deliverables: the different stages in which content will be delivered to Europeana using the ECK follow the development iterations of the connection kit. The development phases that are described in *D2.5 Technical Specification* and *S6.2 Technical Specification* were taken into account to draft the **ingestion plan.** 

The availability of content in the ingestion plan was provided by the content partners in the **ingestion** plan forms.

In the course of the project the ingestion plan will continuously be updated. The **content monitoring forms** that are each month filled out by the content partners make it possible to monitor content progress.

The ingestion plan and the content monitoring forms will be used for the future deliverables of WP4 that report on the results of the testing and feedback from the 4 iterations:

- D4.1(v2) Control Export Evaluation Report (M20, November 2013): update of D4.1(v1) Control Export Evaluation Report (M16, July 2013): evaluation of the control export of the participant records using the ECK prototype iteration 1 and 2.
- D4.3 (v1) Export Evaluation Report (M26, May 2014), D4.3 (v2) Export Evaluation Report (M29 – August 2014): evaluation of the full export of the participant records using the ECK prototype iteration 3 and 4.
- D4.4 Content Re-ingestion Report (M26, May 2014): evaluation of the Europeana Inside tools to re-ingest content back into the system of the content providers.
- D4.5 (v1) Summative Evaluation Report (M26, May 2014) and D4.5 (v2) Summative Evaluation Report (M29, August 204): evaluation of all export and re-ingestion activity and highlighting key issues for the final technical implementation.

### 1.3 Approach

To draw up the ingestion plan, content partners were informed on their tasks and information on their content delivery plans was centralised by:

- Content Providers Meetings: partners were reminded on the objectives of WP4 and were pointed out on their responsibilities as to the amount of records that need to be delivered to Europeana according to the Description of Work (DoW).
- Ingestion Plan Forms were sent to the content providers to inquire about their content delivery schedule, contact information and the status of the Data Exchange Agreement (DEA) signing.
- To assure that content ingestion to Europeana will run smoothly in the upcoming iterations, questions were asked to the content providers about their knowledge on aggregators and their acquaintance with LIDO mapping.

To monitor the ingestion process and the activities of the content partners on WP4, every partner is obliged to fill out monthly the **content monitoring form.** 

The form gathers information on:

- The amount of records that was sent to the (dark) aggregator and to Europeana. Based on these results, the content ingestion plan will be updated
- · Other activities in regard to content delivery
- Possible issues

#### 1.4 Structure of the deliverable

This deliverable is divided into:

- **Content preparation**: tasks performed in preparation of the ingestion plan (content providers meetings and ingestion forms) and in preparation of content ingestion (aggregator).
- **Ingestion plan**: schedule that describes the status and the availability of the collections to be ingested by each content provider starting from the table in the DoW.
- **Monitoring ingestion process**: the ingestion plan will be updated with the information provided monthly by the content partners in the content monitoring forms.

## 2 Content preparation

### 2.1 Content Providers Meetings

There were three Content Providers Meetings with representatives of the Europeana Foundation in which content partners received information on what was expected from them in WP4:

- 1. Content Providers Meeting in Berlin in M4 (July 2012) (part of the first Networking Event)
- 2. Additional Content Providers Meeting in Brussels in M7 (October 2012)
- 3. Content Providers Meeting in Budapest in M15 (June 2013) (part of the second Networking Event)

#### The following topics were discussed:

### Reminder of the objectives of WP4 and the tasks of the content partners within the WP

- Objectives
  - The use of the Europeana Connection Kit (ECK) for the ingestion of 960,000 records into Europeana
  - The 2-stage approach for content ingestion: 1. Test ingest 2. Full ingest
  - Content partners need to evaluate the robustness of the prototype of the Europeana Connection Kit (ECK) to refine the technical specifications
  - Some of the content partners will participate in a pilot to evaluate the potential of the ECK for the dynamic re-ingestion of enriched metadata and User Generated Content (UGC)
- Content partners are responsible for timely content delivery using ECK
- Reminder of the data that each content partner is required to deliver according to the DoW.
- To deliver content to Europeana within the Europeana Inside project, content partners are required to prepare the selection of data according to the requirements and specifications for contributing to Europeana (e.g required fields). They need to provide an URL to the online published record and/or an URL to the online published photograph.

## 2.2 Ingestion Plan Form

In M9 (December 2012) a **content ingestion plan form** was sent to all content partners to collect information on the **availability** of their content for the **test content ingest** and **full content ingest** of their data into Europeana. In addition questions were asked about the status of the DEA signing and contact information was assembled. Every content partner submitted the form and every partner signed the DEA.

The questionnaire was composed of 15 fields (see appendix I):

## 2.3 Content delivery

Europeana Inside has a total of **thirteen content providers** that will deliver content to Europeana.

After the release of iteration 2 (M18, September 2013) **full content ingestion** will start. The ECK will help content providers in this content delivery process, but Europeana Inside will work with aggregators to deliver the records. Every content provider will need to provide a valid LIDO for content ingestion.

Content providers were asked in the first **Content Provider Survey (M3, June 2012)** about their experiences with aggregators and other European projects.

Five of the thirteen content providers have an aggregator relation and can use this service for delivery within Europeana Inside.

From the remaining content partners were six that delivered content to Europeana before using a tool developed within a previous project (e.g MINT) and two that had never delivered to Europeana.

Within Europeana Inside those eight content partners will be able to use the Inside Dark Aggregator which will be developed by Knowledge-Integration (K-INT). The Dark Aggregator will make use of ECK components. It will pass the data through to Europeana, adding the minimum number of extra metadata elements as required by the guidelines for contributing to Europeana.

Content partners have three options to upload their metadata:

- Via a web form
- Pushed using SWORD (Simple Web-service Offering Repository Deposit): a lightweight protocol for depositing content into repositories
- Harvested using OAI-PMH (Open Archives Initiative Protocol for Metadata Harvesting): allows item records to be automatically pulled into the Inside Dark Aggregator. Content partners will have to provide details of their OAI-PMH repository.

## 3 Ingestion Plan

The **ingestion plan** describes the **status** and the **availability** of the collections to be ingested by each content provider starting from the table in the DoW.

The **ingestion forms** were used to compose this schedule. The aim of this plan is to have a clear view on the data that is ready to be ingested ( $N^{\circ}$  of records per month and Total  $n^{\circ}$  ready by date...) and to monitor the ingestion progresses (Total  $n^{\circ}$  ingested in EUR). It is a working document: it monitors ingestion into Europeana and will be continuously updated in the course of the project.

The availability of the data is linked to the four iterations and the reporting periods (*Iterations & Deliverables*) and to the tasks to be carried out by the content providers (*Tasks*).

There is a distinction between:

- N° of records per month: indicates the availability of records by every content provider per month (e.g. in M21 (December 2013) 16,497 records will be ready, provided by four content partners: SPK, RBNIS, NAG and SEI).
- 2) Total n° ready by date...: the availability of the total amount of records ready to be ingested by a certain date (e.g. in M21 (December 2013) a total of 855, 580 records will be ready, provided by a total of eleven content partners: KU Leuven, CT, SLV, HIM, SEI, PIM, SLV, MNM/HNM, BEN, NAG and RBNIS)

The ingestion plan also shows that several content partners will **provide their content in different phases**. The National Gallery-Alexandros Soutzos Museum – NAG (GR) for example will have their data ready in three steps:

- 1/3: 3000 records in M20 (November 2013)
- 2/3: 3000 records in M21 (December 2013)
- 3/3: 3000 records in M22 (January 2014)

The ingestion plan considers the indicators in the DoW:

- Indicator 6: Number of records successfully exported into Europeana using the prototype Europeana Connection Kit in the initial pilot export: 100 000
- Indicator 7: Number of records successfully exported into Europeana using the prototype Europeana Connection Kit in the initial pilot export: 960 000

In the table below the columns of the Ingestion Plan are clarified (see appendix II for the full ingestion plan).

## 4 Monitoring Ingestion Process

The role of WP4 is to monitor any changes or delays in the content delivery. The goal is to keep unvaried the overall amount of content that the project is committed to deliver to Europeana using the ECK.

The ingestion process is closely monitored by the WP4 lead through the monthly **Content Monitoring Form**. The forms were distributed to all content partners through Basecamp in M13 (April 2013) (see appendix III).

By making use of these forms the timely follow-up of **content preparation** (publishing records on online catalogue...) and **content ingestion into Europeana** is guaranteed. Any issues that may emerge can be filled out on the form. The ingestion plan will be updated based on the information provided by the content partners in these forms. The progress forms are to be handed in by the 5th of the following month to the WP4 lead.

Almost all content partners completed the content monitoring forms for M13 (April 2013), M14 (May 2013) and M15 (June 2013).

The most frequent **tasks** that were executed during that period were: selection and preparation of test records, publishing records on their website, creation of object groups in the CMS, data harmonization, meetings with their technical partner, revising of the LIDO mapping and the testing and evaluation of iteration 1 ECK.

The partners reported on **issues** with the testing of iteration 1 ECK and the LIDO mapping. Most problems were discussed on Basecamp. Content partners that made fewer use of Basecamp, argued that their issues were internal and considered not to be important for the rest of the group.

Since the start of full content ingest is planned in M20 (November 2013), no metadata has been provided to the aggregator using the ECK yet.

## 5 Results and next steps

All content partners completed the **ingestion plan forms** in which they confirmed the timely availability of the content as specified in the DoW. A staggered content export schedule was drafted based on the input from the content partners in those forms: the content **ingestion plan**.

The plan shows the amount of records that will be ready for ingestion each month and the content providers that will deliver them. **Content ingestion will be closely monitored** by the WP4 lead in the upcoming iterations. The ingestion form will be updated as records will be ingested in Europeana. All delivered content to Europeana will be added to the ingestion plan (*Total n*° *ingested in EUR*).

Content providers report monthly on their content deliveries and other activities in the **content monitoring form**. It is the responsibility of every content partner to make sure that the amount of records mentioned in the content ingestion plan form is ready for ingestion in the indicated time.

The **full content ingestion** will start in M20 (November 2013) after the release and testing of iteration 2 in M18 and M19 (September and October 2013).
