


The website (www.project-forward.eu) was launched in December 2013. We approached the project's website as a continuous work in progress. CRB is responsible for the actual conception of the online platform and for the fundamental changes to the structure of the website. Once the initial planning, design, development and testing of the website were completed by CRB, regular updates and news items were added by ACE.

CRB used the widely known blog tool, publishing platform and content management system **WordPress** to create the website. The unpretentious, user-friendly and clear design of the chosen theme fits it purpose.

During the course of the project's first year, and due to the late start if the project, there won't a substantial influx of news to feed to the website. We expect this to improve in the next two years. CRB & ACE mainly prioritize the primary function of the project's website: to be the main entry point for stakeholders and other third parties to access information about FORWARD, to be visible for those who have any interest in the matter at hand. All the partners are presented on the online platform as well, visitors can find links to their respective websites.



The website provides public as well as internal information. The public section provides general information about the project and the consortium members. Publicly available project results and presentations are easily found under 'Results' and news and events related to the subject are published on the home page.

The restricted section contains all the project documents, deliverables and other outputs. This shared working space mirrors the internal functioning and the development of the project. ACE regularly feeds this section with useful dissemination documents, for instance the project factsheet.

The restricted area is divided in WP-sections with a vertical menu to facilitate the surfing of the website's visitors. This user-friendly solution allows the partners to find the documents of the different work packages easily.
