Explanation of logo

The OpenUp! project shall bring the abundance of specimens stored within natural history collections "to life" and this new life is symbolized by a small bird, an intermediate creature something between a tiny phoenix, a revived study skin and the spirit of discovery. This optimistic, promising symbol is shown escaping a box which can be recognized in the OpenUp! lettering: a box being opened as the imperative claims. This box as a symbol acts for all the barriers which have been making collection materials inaccessible. These obstacles are to be set aside, as the lid of the box is.



The left-hand orientation of the symbol allows its use at the beginning of headings, particularly in front of the "OPENING UP THE NATURAL HISTORY HERITAGE" lettering, giving it slight feeling of motion, as if it had just struck the box, previously closed up to that very moment.

The official OpenUp! logo is published in http://open-up.eu/content/open-logo. The logo is provided in several versions, each suitable for specific use. All logos have a transparent background with the exception of one low-resolution version of the simple logo, which has a white background. There are two basic types of the logo: a simple logo and a logotype including the whole name of the project (logoPlusText). The basic, simple version is provided in both high and low resolutions. Moreover, for black and dark backgrounds, negative versions of the logo (white logo) are also included. All logos are in PNG format; a version of the logo in Al format will be also included for both the white and black versions. These are intended for needs of graphic designers. Please do not create your own negative versions from the basic black version, as the result is not identical to the one provided.
